DEADLINES:	SIGN-UP DEADLINE: Monday, Oct. 2 Parent must sign dancer up ONLINE by Monday, Oct. 2, 2023. NO EXCEPTIONS!	OPT-OUT DEADLINE: Wednesday, Nov. 1 After Nov. 1, 2023, all costs will apply, including costume fees and participation fee.

ADDITIONAL INFO:	For our Holiday Show ONLY , dancers who take multiple dance classes can choose which classes they perform with.	Dancers will perform 1 number for EACH style of dance they are enrolled in.
TICKETS:	Each year, Alpine Dance Academy strives to present professional and memorable shows to our audience. Ticket sales are necessary to offset the cost of our productions. All show attendees (including parents) must purchase a ticket for each show that they would like to watch. Thank you!	

Alpine Dance Academy Registration Agreement – 2023-2024

By registering for our 2023-2024 season, you have agreed to the following:

TUITION: (autopay available)

I understand that Annual Tuition can be paid in one of two ways:

- 1. Prepay the entire year of tuition and receive a **5% Discount**. (Due by Sept. 30th)
- 2. Pay Tuition monthly, in **10 Equal Installments**. Payment amount is the <u>same each month</u> regardless of how many dance weeks there are in a month. Please note that choosing to pay monthly does not grant "month to month" participation. If your dancer must miss a class, make-up options may be available.

IF PAYING MONTHLY: I understand that tuition is due the **FIRST CLASS OF EACH MONTH**. There will be a **\$5.00 LATE FEE** added to my account for each monthly payment that I make after the first week of the month, **NO EXCEPTIONS!** Payments can also be made online at mydanceworks.net. (Contact the office for an account set-up link.)

JUNE RECITAL:

By registering for the 2023-2024 dance season, I agree that my dancer will participate in Alpine Dance Academy's annual Recital held in June of 2024 which includes mandatory rehearsals and/or performances from June 10th-June 15th. I understand that my dancer <u>MUST PARTICIPATE IN ALL REQUIRED DATES</u>. *Additional charges such as costume fees and a participation fee will apply. If you choose <u>NOT to participate</u> in our annual June Recital, you <u>MUST notify the office by November 1, 2023</u>. If you do not notify the office by Nov. 1st, <u>ALL recital charges WILL APPLY</u>, including Recital Fee and Costume Fees.

NEWSLETTERS AND ANNOUNCEMENTS:

I understand that important studio information will be passed on to me during the year through monthly e-newsletters, text messages, and printed reminders. I agree to read all of the above listed materials in order to stay up to date and informed on studio news. (This helps our year to run smoothly!) Information can also be found on our website at alpinedance.com.

DRESS CODE / ARRIVAL:

I understand that it is VERY IMPORTANT for my dancer(s) to arrive to class ON TIME AND IN DRESS CODE, INCLUDING HAIR AND SHOES! (Please have your child use the restroom before class begins!)

ARRIVAL / DISMISSAL:

I understand that I am to **wait outside** with my dancer upon arrival, until my dancer is **invited in to the studio** by a staff member. Parents must also wait **outside** for dancers to be dismissed from class. (This ensures your dancer's safety as we will disperse them to you one at a time.) I also understand that **food and drinks are <u>NOT PERMITTED</u> in the studio** (except for water). Thank you!

RELEASE OF LIABILITY:

As the legal parent, guardian, or participant, I release and hold harmless Alpine Dance Academy, and its owners and operators from any and all liability, claims, demands and causes of action whatsoever, arising out of, or related to any loss, damage, injury or illness, including death, that may be sustained by the participant and/or the undersigned, while in or upon the premises or any premises under the control and supervision of Alpine Dance Academy, its owners and operators or in route to or from any of said premises.
